The individuals are supported in making their own decisions, with their support team, to create the life they want. Staff are trained to help the people we serve explore hobbies and build relationships in the community where they live. We also a residential service that provides support to help individuals with intellectual/developmental disabilities live as independently as possible. Support can be provided in the home or apartment and can for a few hours a day up to 24 hours a day.

Mainstreet Marketing Enterprises LLC performs light manufacturing services to both owned and partnered brands out of our facility in Lebanon, IN. The majority of our 50 employees are part-time with at least one diagnosed disability. Most of the company's labor hours are spent manufacturing its wholly-owned national brand of seed-filled finch feeders called Mr. Canary.
